		Compensation for winning party: for 1/a or 1/b and for 2/a or 2/b: CHF 1'000 each	
		The losing party is usually responsible for the proceeding costs (CHF 800) and for paying damages to the winning party in the range of CHF 1'000 (1/a or 1/b) to 2'000 (2/a or 2/b).	
		If opponent: Compensation for official fees

	Deadline	Filing of appeal (appellant)	Court fees: around CHF 4'000
